have been filed in the office of the Secretary of State on the 20th day of JULY A. D., 19 73, as provided by the Laws of the State of Oklahoma.

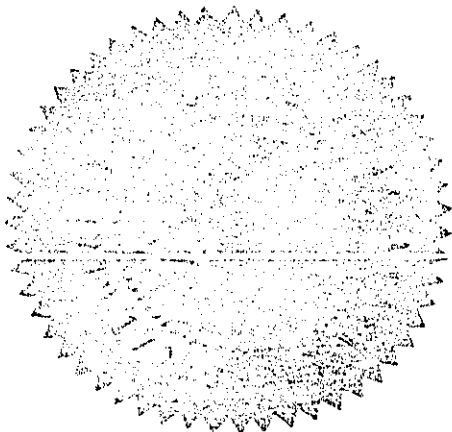

WE, the undersigned trustees or directors,

being persons legally competent to enter into contracts, for the purpose of forming a corporation under the laws of the State of Oklahoma, (18 O.S. Sections 541-594), do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation is:

OKLAHOMA ASSOCIATION OF STUDENT COUNCILS *ex 73*

ARTICLE II

The address of its registered office in the State of Oklahoma is 2405 N. W. 16th Street, Oklahoma City, Oklahoma, 73107, and the name of its registered agent at such address is Gladys Flood.

ARTICLE III

The duration of the corporation is fifty (50) years.

ARTICLE IV

The purposes for which the corporation is formed are:

1. To aid in the educational processes of the Student Councils across the State of Oklahoma;
2. To conduct workshops and activities for the various Student Councils who are members of this corporation, and to provide information for the various Student

Councils and individuals who are members of the corporation, and to provide them with educational materials as to the educational processes relative to Student Councils in the State of Oklahoma;

3. To further education in the State of Oklahoma through the various Student Councils;

4. To provide leadership and leadership proceedings for the members through Student Councils throughout the State of Oklahoma;

5. To provide communication between Student Councils throughout the State of Oklahoma;

6. To aid in national, state and district workshops for Student Councils;

#### ARTICLE V

The corporation is not organized for pecuniary profit, nor shall it have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any member, director, trustee or individual. The balance, if any, of all money received by the corporation from its operations, after the payment in full of all debts and obligations of the corporation of whatsoever kind and nature, shall be used and distributed exclusively for carrying out only the purpose or purposes of the corporation particularly set forth in Article Four (4) herein.

In the event of dissolution of this corporation, or in the event it shall cease to carry out the objects and purposes herein set forth, all the business, property and assets of the corporation shall go and be distributed to such nonprofit corporation of like purpose or purposes as set forth in Article Four (4), as the directors of this corporation may select and designate; and in no event shall any of the said assets or property, in the event of dissolution, thereof, go or be distributed to members, either for the reimbursement of any sum subscribed, donated or contributed by such members, or for any other such purpose or purposes.

#### ARTICLE VI

The number of directors to be elected at the first meeting of the trustees is three (3), but this number may be amended by the by-laws of this corporation.
